AMENDED TWENTY-SECOND AMENDMENT TO MASTER DEED OF ROBBINS BROOK CONDOMINIUM

(adding Phase <u>19)</u> Acton, Massachusetts

WHEREAS the undersigned, NIC REALTY, LLC a New Hampshire limited liability company having its principal office at 254 Nashua Road, Londonderry, New Hampshire 03053 ("NIC"), is the Assignee in a certain Assignment and Conveyance of Development Rights dated April 5, 2005 recorded in the Middlesex South District Registry of Deeds (the "Registry") in Book 44951 at Page 100 (the "Assignment"); and

WHEREAS the Assignment permits NIC to construct certain Town Home Units and to add the same to the Robbins Brook Condominium (the "Condominium") created by Master Deed dated January 23, 2002 and recorded on January 24, 2002 in the Registry in Book 34644 at Page 63, as amended of record (the "Master Deed");

NIC hereby amends the Master Deed to create Phase 19 of the Condominium, as shown on the Plans recorded with said Deeds in Plan Book 2010, Page 891 to be governed by and subject to the provisions of Chapter 183A of the General Laws of Massachusetts (the "Act").

1. <u>Description of Phase 19.</u>

Phase 19 consists of Units 62, 63, 64, and 65 as described in Section 7A of the Master Deed. The location of Units 62, 63, 64 and 65 are designated as "Unit 62", "Unit 63", "Unit 64" and "Unit 65" on a site plan entitled "As built Site Plan Units 62, 63, 64 and 65 The Robbins Brook Condominium in Acton, MA", and recorded in Plan Book 2010, Page 891 (the "Phase 19 Site Plan").

2. <u>Description of Phase 19 Units.</u>

- i. The Unit designation of each of the Phase 19 Units, a statement of its location, approximate area, number of rooms, and immediate common areas to which it has access, and its proportionate interest in the common areas and facilities of the Condominium are as set forth in said Master Deed, said aforementioned plan and floor plans recorded in Plan Book 2010, Page 891, and in Exhibits B-1, C-1 and D attached hereto.
- ii. The boundaries of each of the Phase 19 Units and its appurtenances are as defined in Section 7A of the Master Deed, as amended.
 - iii. The land on which the Phase 19 Units are constructed (the "Phase 19 Land"), and the Exclusive

4 Proxim Way and 17 in 19 Herallon Way, Asker MA

Use Area appurtenant to each Phase 19 Unit is described on the Phase 19 Site Plan. The Phase 19 Land has the nonexclusive easement and right to pass and re-pass over the streets and ways shown on the condominium site plan recorded with the Master Deed for access to and egress from the Phase 19 Land.

3. <u>Description of Common Areas and Facilities</u>.

The common areas and facilities with respect to Phase 19 are as defined in Sections 7A and 8 of the Master Deed.

4. Floor Plans.

A set of the floor plans of the Phase 19 Units, showing the layout, location, unit designation and dimensions of the Units, and bearing the verified statement of a registered professional engineer certifying that said plans fully and accurately depict the layout, location, unit designation and dimensions of the Phase 19 Units as built are recorded with said Deeds in Plan Book 2010, Page 891.

5. <u>Incorporation of Existing Provisions of Master Deed.</u>

Except as described and amended herein, the Phase 19 Units and the common areas and facilities of Phase 19 shall be subject to and shall have the benefit of all of the provisions of the Master Deed. The provisions of the Master Deed (except as the context thereof clearly indicates to the contrary) are hereby incorporated by this reference into this Amended Twenty-second Amendment to Master Deed as if set forth herein verbatim.

This instrument supplements the Amendment previously recorded with said Deeds in Book 56120, Page 165. The Exhibits to said Amendment were inadvertently omitted: Exhibits B-1, C-1 and D. Exhibit C-1 also reflects new percentage interests.

EXHIBIT B-1 TO THE MASTER DEED OF ROBBINS BROOK CONDOMINIUM DESCRIPTION OF BUILDINGS

The building in which Units 62 and 63 are located is a two (2) story building on a concrete slab. The building is wood, with wood joists. The roof is asphalt shingle.

Unit 62 contains first floor and second floor levels.

The first floor level contains a country kitchen, combination living room and dining room, master bedroom, master bathroom/ laundry room, powder room, garage, and deck.

The second floor level contains a bedroom, a bathroom, study, and loft.

Unit 63 contains first floor and second floor levels.

The first floor level contains a country kitchen, combination dining room and living room, powder room, garage, enclosed porch.

The second floor level contains a master bedroom, a master bathroom, a bedroom, a bathroom, storage/utility room, and loft.

The building in which Units 64 and 65 are located is a two (2) story building on a concrete slab. The building is wood, with wood joists. The roof is asphalt shingle.

Unit 64 contains first floor and second floor levels.

The first floor level contains a country kitchen, combination living room and dining room, powder room, garage, and enclosed porch.

The second floor level contains a master bedroom, a master bathroom, a bedroom, a bathroom, storage/utility room, and loft.

Unit 65 contains first floor and second floor levels.

The first floor level contains a country kitchen, combination living room and dining room, master bedroom, master bathroom/ laundry room, powder room, garage, and deck.

The second floor level contains a bedroom, a bathroom, study, and loft.

SCHEDULE C-1 TO THE MASTER DEED ROBBINS BROOK CONDOMINIUM PERCENTAGE INTEREST

The following table sets forth the type Units that are currently extant and proposed, and the undivided interests in the common areas and facilities appurtenant to each group of units.

Fifty-four (54) Town Home Units are now proposed to be built and added to the Condominium. Four (4) Town Home Units are being added by this Amendment to the Master Deed. As each Town Home Unit is added to the condominium, the percentages of undivided interest in the common areas and facilities will be calculated as set forth in the Act. If additional land and/or Units are added to the condominium in the future, the same procedure shall be followed with respect to such Units.

<u>Column 1</u> headed "Units" describes the unit(s). There are four types of units: The Assisted Living Unit, 24 Independent Dwellings, 31 Village Homes, and 54 proposed Town Homes, all of which are described in Section 1A of the Master Deed, as amended. Four (4) Town Home Units are being added to the condominium by this Amendment to the Master Deed.

<u>Column2</u> headed "Number of Units" sets forth the number of units in a unit group. The unit groups are the Assisted Living Unit, 24 Independent Dwellings, 31 Village Homes, and 54 contemplated Town Homes to be built and added to the condominium. See sections 5, 6, 7, and 7A of the Master Deed, and Sections 5.4, 5.4.9, 5.4.17 and 5.4.25 of the Condominium Trust.

Column 3 headed "Total Undivided Percentage Interests of the Group" sets forth the aggregate of all undivided percentage interests in the common areas and facilities appurtenant to all units in a group when all contemplated units have been added to the Condominium. Certain expenses are shared only by the owners of units in a designated subgroup – see Sections 5, 6, 7 and 7A of the Master Deed, and Sections 5.4, 5.4.9, 5.4.17 and 5.4.25 of the Condominium Trust.
